Ágæta Alþingi / Dear Members of the Parliament:

Our registered international physicians' charity, Doctors Opposing Circumcision, respectfully asks you to please support the proposed restrictions on male circumcision in Iceland –unless there is proven medical need.

We believe that Iceland has this obligation under the United Nations Convention on the Rights of the Child which Iceland has ratified. That UN Convention, at Art 24, sec. 3. declares:

As you will know, 'medicalised' circumcision was a puritanical invention of Englishlanguage doctors before the discovery of germs. It has NO place in modern medical care except for consenting adults or proven medical need. Claims that such a restriction will drive religious minorities from Iceland are an exaggeration, pure scare-tactics, as the practice is not a 'sine qua non' in either religion.

Moreover, we need to protect the religious freedom of the BOY himself. Not everyone stays with his family's religious heritage, and the child's future choices need to be preserved. Parents do not own their children, and cannot do as they please to their child's body.

Your example may start an important worldwide conversation about the worthiness of ancient practices injurious to children, which the United Nations Convention on the Rights of the Child recognizes as a universal concern.

Once again, we urge you, respectfully, to please support the ban in Iceland on non-medical, merely cultural, unnecessary, male circumcision.
