Knowing that for pure commercial purposes the Icelandic government authorizes the killing of 1800 whales in a certain number of years leaves me speechless and risks making me change my opinion on the wisdom of the rulers of the Icelandic people. The killing of intelligent, sensitive mammals and their young is an abominable and unjustified crime perpetrated against free-born marine beings and to all of humanity. An enlightened government, in the perhaps irreversible crisis of the modern world, should study and adopt alternative strategies, such as those of the Azores, where whales have become a driving force for ethical tourism, work on the image of a small, big island lost in the vastness of the sea which becomes a lighthouse and example for the whole world by adopting safeguard policies, not pure destruction of life. Like me, millions of other people around the world are thinking of boycotting tourism in Iceland, of no longer even being interested in the music of Icelandic groups like Sigur Ros, of deleting from their desktop any reference to a country that for pure economic reasons destroys a monument to life: the Whale. I hope you will understand the profound reasons that inspire my little message, if you had ever swum in the company of a whale perhaps you would perceive how thin the border is between from what we proudly define as human and what we define as animal. Feeling, listening, understanding, loving. I hope it's not already too late for you, every wrong choice will be paid hard over time.
